Appellants, Bankers Hill 150, et al. (collectively "Appellants") respectfully oppose the publication of this Court's January 7, 2022 Opinion in the above-referenced case ("Opinion") as requested by the California Building Industry Association ("CBIA") and the Building Industry Association – Bay Area ("BIABA") (collectively, "Building Industry") and Greystar GP II, LLC, Real Parties in Interest and Respondents.

As Respondent City of San Diego's Opposition to Request for Publication notes, the Density Bonus Law issue discussed at length in the Opinion was not briefed in this appeal. The potential for a published opinion to have broad implications regarding an issue not briefed by the parties further supports the Court's original decision to not certify this Opinion for publication, as well as Appellants' and Respondents' opposition thereto.

Additionally, the Opinion does not support the reasons for publication as provided in Rule 8.1105(c) of the California Rules of Court, and the two requests for publication do not show otherwise. The facts of this case do not differ significantly from those in other published opinions; rather, the Opinion merely applies an existing rule of law to a set of facts similar to facts in other cases.
